### Pastors' Views on Economic Impact

A SURVEY OF AMERICAN PROTESTANT PASTORS

### Methodology

- The phone survey of 1,003 Protestant pastors was conducted August 8 – September 3, 2024
- The calling list was a stratified random sample, drawn from a list of all Protestant churches. Quotas were used for church size
- Each interview was conducted with the senior pastor, minister or priest at the church
- Responses were weighted by region and church size to more accurately reflect the population
- The completed sample is 1,003 surveys
- The sample provides 95% confidence that the sampling error does not exceed <u>+</u>3.3% This margin of error accounts for the effect of weighting
- Margins of error are higher in sub-groups


### Methodology

- Comparisons are also made to the following telephone surveys using probability sampling:

  - 1,000 pastors conducted March 1-9, 2010
  - 1,000 pastors conducted October 7-14, 2010
  - 1,002 pastors conducted January 17-27, 2011
  - 1,000 pastors conducted May 18-25, 2011
  - 1,000 pastors conducted May 23-31, 2012
  - 1,000 pastors conducted September 11-18, 2014
  - 1,000 pastors conducted January 8-22, 2016
  - 1,000 pastors conducted August 30 September 18, 2017
  - 1,000 pastors conducted August 29 September 11, 2018
  - 1,000 pastors conducted August 30 September 24, 2019
  - 1,007 pastors conducted September 2 October 2, 2020\*
  - 1,000 pastors conducted September 1-29, 2021
  - 1,000 pastors conducted September 6-30, 2022
  - 1,004 pastors conducted August 29 September 20, 2023

# 66% say that the current economy is having a negative impact on their church






### Pastors' perceptions of negative economic impact is the highest since 2011 (14% Very negatively is the highest recorded)


**Among Protestant Pastors** 

■ Very negatively ■ Somewhat negatively ■ No impact ■ Somewhat positively ■ Very positively




### 50% say that giving for 2024 is about what was budgeted; 29% say it is lower than budgeted

**Among Protestant Pastors** 




# 29% say that giving for 2024 is higher than 2023

### **Significant Statistical Differences**

Comparisons were made to determine if there are any significant statistical differences among the church's region, denomination group, and average worship attendance.

### **Significant Statistical Differences**

Comparisons were made to determine if there are any significant statistical differences among political party and presidential candidate.

#### "How is the current economy impacting your church?"

- Pastors age 45-54 (73%) are more likely to select "Very or somewhat negatively" than pastors age 65+ (61%)
- Male pastors are more likely to select "Very or somewhat negatively" than females (67% v. 58%)
- Pastors who are White (67%) and Other ethnicities (67%) are more likely to select "Very or somewhat negatively" than African American pastors (49%)
- African American pastors (36%) are more likely to select "The economy is having no impact on my church" than White pastors (23%)
- Pastors with no college degree (69%) or a Bachelor's Degree (70%) are more likely to select "Very or somewhat negatively" than those with a Doctoral Degree (56%)
- Evangelical pastors are more likely to select "Very or somewhat negatively" than Mainline pastors (71% v. 60%)
- Pastors in the West (71%) are more likely to select "Very or somewhat negatively" than those in the Northeast (58%)

#### "How is the current economy impacting your church?" Continued

- Methodists (30%), Presbyterian/Reformed (32%), and Non-denominational (31%) are more likely to select "The economy is having no impact on my church" than Baptists (19%), Lutherans (20%), and Christian/Church of Christ (14%)
- Republicans are the most likely to select "Very or somewhat negatively" (79%)
- Democrats (21%) are more likely to select "Very or somewhat positively" than Republicans (2%) and Independents (9%)
- Democrats (34%) are more likely to select "The economy is having no impact on my church" than Republicans (18%) and Independents (24%)
- Pastors planning to vote for Donald Trump are the most likely to select "Very or somewhat negatively" (83%)
- Pastors planning to vote for Kamala Harris (35%) and pastors who are undecided (28%) are more likely to select "The economy is having no impact on my church" than pastors who are planning to vote for Donald Trump (15%)

#### "Since the beginning of 2024, have your offerings been?"

- Pastors age 45-54 are the most likely to select "Lower than budgeted" (38%)
- Pastors age 55-64 (55%) are more likely to select "About what we budgeted" than pastors age 45-54 (44%)
- Evangelical pastors are more likely to select "Lower than budgeted" than Mainline pastors (34% v. 24%)
- Mainline pastors are more likely to select "About what we budgeted" than Evangelical pastors (55% v. 47%)
- Presbyterian/Reformed (60%) are more likely to select "About what we budgeted" than Baptists (49%), Lutherans (47%), and Pentecostals (39%)
- Pastors at churches with attendance 0-49 are the least likely to select "Higher than budgeted" (11%)
- Republicans (36%) are more likely to select "Lower than budgeted" than Democrats (17%) and Independents (28%)
- Democrats (58%) are more likely to select "About what we budgeted" than Republicans (46%)

#### "Since the beginning of 2024, have your offerings been?" continued

- Pastors planning to vote for Donald Trump (39%) and pastors who are undecided (31%) are more likely to select "Lower than budgeted" than pastors planning to vote Kamala Harris (19%)
- Pastors planning to vote for Kamala Harris (61%) are more likely to select "About what we budgeted" than pastors planning to vote for Donald Trump (45%) and pastors who are undecided (47%)

## "Compared to your calendar year 2023 offerings, have your total offerings so far for 2024 been ..."

- Pastors age 55-64 (40%) and 65+ (42%) are more likely to select "The same as 2023's offerings" than pastors age 18-44 (31%)
- Pastors with a Master's Degree (34%) are more likely to select "Above 2023's offerings" than those with no college degree (22%) or a Bachelor's Degree (21%)
- Mainline pastors are more likely to select "Above 2023's offerings" than Evangelical pastors (36% v. 25%)
- Evangelical pastors are more likely to select "Below 2023's offerings" than Mainline pastors (28% v. 19%)
- Lutherans (38%) and Presbyterian/Reformed (38%) are more likely to select "Above 2023's offerings" than Baptists (19%), Methodists (26%), and Pentecostals (25%)
- Pastors at churches with attendance 0-49 are the least likely to select "Above 2023's offerings" (20%)

### "Compared to your calendar year 2023 offerings, have your total offerings so far for 2024 been ..." *continued*

- Democrats (41%) are more likely to select "Above 2023's offerings" than Republicans (25%) and Independents (30%)
- Pastors planning to vote for Kamala Harris (39%) are more likely to select "Above 2023's offerings" than pastors planning to vote for Donald Trump (23%) and pastors who are undecided (28%)
- Pastors planning to vote for Donald Trump (31%) and pastors how are undecided (27%) are more likely to select "Below 2023's offerings" than pastors planning to vote for Kamala Harris (12%)

## "Approximately what percentage are your calendar year 2024 offerings above/below 2023's offerings?"

- Pastors age 65+ (48%) are more likely to select "Same as 2023" than pastors age 18-44 (36%)
- Pastors age 18-44 (15%) are more likely to select "Above by 1% to 9%" than pastors age 65+ (8%)
- African American pastors (11%) are more likely to select "Above by 25% or more" than White pastors (3%)
- Pastors who are Other ethnicities (8%) are more likely to select "Below by 25% or more" than White pastors (3%)
- Pastors with a Master's Degree (14%) or a Doctoral Degree (16%) are more likely to select "Above by 1% to 9%" than those with no college degree (6%) and a Bachelor's Degree (8%)
- Pastors with a Master's Degree (13%) are more likely to select "Above by 10% to 24%" than those with a Bachelor's Degree (6%)
- Evangelical pastors are more likely to select "Below by 10% to 24%" than Mainline pastors (15% v. 9%)

## "Approximately what percentage are your calendar year 2024 offerings above/below 2023's offerings?" Continued

- Pastors in the South (14%) and West (16%) are more likely to select "Below by 10% to 24%" than those in the Northeast (6%)
- Pentecostals (22%) are more likely to select "Below by 10% to 24%" than Lutherans (8%), Methodists (10%), and Presbyterian/Reformed (6%)
- Lutherans (18%) and Presbyterian/Reformed (15%) are more likely to select "Above by 1% to 9%" than Baptists (7%) and Pentecostals (6%)
- Pastors at churches with attendance 100-249 (15%) and 250+ (18%) are more likely to select "Above by 1% to 9%" than those at churches with attendance of 0-49 (7%)
- Democrats (17%) are more likely to select "Above by 10% to 24%" than Republicans (9%)
- Pastors planning to vote for Donald Trump (15%) are more likely to select "Below by 10% to 24%" than pastors planning to vote for Kamala Harris (7%)
- Pastors planning to vote for Kamala Harris (15%) are more likely to select "Above by 10% to 24%" than those planning to vote for Donald Trump (8%)
