- 1. All information as of April 15, 2025.
- Some state conventions no longer use the designation of church-type mission to categorize congregations which are not selfdetermining, self-sustaining, and self-propagating. This practice has impacted the number of churches and church-type missions.
- 3. Total impacted by incomplete data from some state conventions. See body of table and notes for details. Care should be exercised in comparing SBC totals to previous years.
- 4. Totals for both Texas conventions and the SBC are impacted by one church with an extensive media ministry reporting 5,259,610. Those totals are not comparable to previous years.
- 5. Adjustments were made to state convention totals as detailed in footnote 12. Previous years' totals for this state convention had no adjustments. Care should be exercised in comparing totals to previous years.
- Florida Baptist Convention did not ask the following items or the information necessary to obtain the items: Other Additions,
  Online Weekly Worship Average Participation, Undesignated Receipts, and Total SBC Mission Expenditures.
- 7. Georgia Baptist Mission Board, Kentucky Baptist Convention, Northwest Baptist Convention, and South Carolina Baptist Convention did not ask the following item or the information necessary to obtain the item: Online Weekly Worship Average Participation.
- 8. Baptist General Convention of Oklahoma did not ask the following items or the information necessary to obtain the items: Online Weekly Worship Average Participation, VBS Enrollment, and Total SBC Mission Expenditures.
- 9. Two state conventions exist within the state of Texas. The Texas summary line does not show the arithmetic sum of the two state convention figures, because some congregations are related to both state conventions and their numbers are reflected in the totals for both state conventions.
- 10. Two state conventions exist within the state of Virginia. The Virginia summary line does not show the arithmetic sum of the two state convention figures, because some congregations are related to both state conventions and their numbers are reflected in the totals for both state conventions.
- 11. This line includes four types of adjustments to the data:
- a. The removal of duplicate data caused by 934 congregations that are related to more than one state convention.

- $b. \ The \ removal \ of \ data \ from \ 244 \ congregations \ affiliated \ with \ a \ state \ convention \ but \ not \ related \ to \ the \ SBC.$
- c. The addition of data from 1,521 congregations affiliated with the SBC but not related to a state convention.
- d. The addition of data carried forward from previous ACP reporting cycles for 19,442 congregations that did not report an item in 2024.
- 12. Adjustments to the national totals (and some state convention totals) include data carried forward for non-reported items from data reported in prior years.
  - a. Totals include carried forward Total Membership from the last year the congregation reported it.
  - b. Totals include carried forward In-Person Weekly Worship Average Attendance and In-Person Sunday School/Bible Study/ Small Group Average Attendance from the most recently reported data from the prior two years.
- c. Totals include carried forward Undesignated Receipts and Total SBC Mission Expenditures from the most recently reported data from the prior four years.
